# Common Policy Topics (1/8)

---

- IPv4 Depletion
- IPv6 Deployment
- Internet Resources Transfers

## Common Policy Topics (2/8)

---

- IPv4 Depletion
  - ARIN-2012-4, “Return to 12 month supply and reset trigger to /8 in free pool”
  - AfriNIC: Soft Landing Policy; ratified

# Common Policy Topics (4/8)

---

- IPv4 Depletion
  - LACNIC-2011-07, “Modification of Policy 2.3 IPv4 Address Allocation and Assignment Policies”
  - LACNIC-2011-06 reserves a /12 for gradual exhaustion of IPv4 resources; consensus

## Common Policy Topics (5/8)

---

- IPv6 deployment
  - APNIC: prop-102, “Sparse allocation guidelines for IPv6 resource allocations”; consensus
  - APNIC: prop-101, “Removing multihoming requirement for IPv6 portable assignments”
  - APNIC: prop-099, “IPv6 reservation for large networks”

## Common Policy Topics (6/8)

---

- IPv6 deployment
  - LACNIC: 2011-04 makes mandatory to applicants of IPv4 to request IPv6; consensus
  - LACNIC: 2011-03, “Modification of Section 2.3.4”; consensus

# Common Policy Topics (7/8)

---

- IPv6 deployment
  - ARIN: 2012-02, “IPv6 Subsequent Allocations Utilization Requirement”

# Common Policy Topics (8/8)

---

- Internet Resources Transfer
  - ARIN-2011-1, “ARIN Inter-RIR Transfers”
  - ARIN-2011-3, “ASN Transfer”
  - APNIC: prop-095, “Inter RIR IPv4 address transfer”; consensus at APNIC 31

## Overview on Proposal Status (1/3)

---

- 2011-02: Removal of multihomed requirement for IPv6 PI; consensus
- 2011-01: Global Policy for post exhaustion IPv4 allocation mechanisms by the IANA; consensus

## Overview on Proposal Status (2/3)

---

- 2011-04: Extension of the Minimum Size for IPv6 Initial Allocation; Last Call
- 2011-05: Safeguarding future IXPs with IPv4 space; Last Call

## Overview on Proposal Status (3/3)

---

- 2011-06: Abuse Contact Management in the RIPE NCC Database
- 2012-01: Inter-RIR Address Transfers

- Cosmetic Surgery Project
  - Kicked off at RIPE 59
    - Draft in-house
    - APWG Co-Chairs' confirmation
    - Timeline: 15 working weeks per document
    - Six policy documents for review
