I am contacting you on behalf of SI-CERT (Slovenian Computer Emergency Response Team). We have been asked to assist in a case of personal data abuse that is being carried out by one of your customers, freepornia.net.

Thanks for your mail to abuse@leaseweb.com. We have processed your mail and contacted our customer with a request to review your complaint and take appropriate action.

Thank you for your reply. Do you have your Terms of Service or Acceptable Use Policy available on the web? Usually hosting providers regard personal data misuse as violations of their ToS or AUP. Some also regard obscene material also as such.

I rechecked, but the actual website is NOT hosted with us, nor registered. As mentioned in your own email you contacted the right party already.

Strange. Well, you did say in your previous reply that you have contacted your customer:

Hello,

I Just had a quick look at this. The website will be removed today.

To whom it may concern,

My name is Gorazd Bozic and I am contacting you on behalf of SI-CERT (Slovenian Computer Emergency Response Team). We have been asked for help in a case of search results including porn sites.

Ms. works for . When she tried the combination " , the first search result led to www.freepornia.net/ html. She reported this as an abuse of her personal data to you via the provided form sometime before August 20. We have reported this to you as a result that should be filtered by SafeSearch on August 26. The request was denied with the explanation: "The webpage or image you submitted is not currently appearing in our search results." Please see the attached screenshot where freepornia.net is still the first amongst the results. The screenshot was taken today at 09:03 UTC+2.

Please remove this offending site.

- ask US-CERT for help
- "US-CERT has emailed security contacts at both Google and You Tube and requested they comply with your requests."

monkeying with on-line forms

send a mail a day

- nothing happens ...
- we urge them to please do something

DMCA

- copy/paste the DMCA Takedown Notice to Ms. Debra Tucker

DMCA

To Whom It May Concern,

I am writing to you to avail myself of my rights under the Digital Millennium Copyright Act (DMCA). This letter is a Notice of Infringement as authorized in § 512(c) of the U.S. Copyright Law. I wish to report an instance of what I feel in good faith is an instance or Copyright Infringement. The infringing material appears on the Service for which you are the designated agent.

You are registered with the U.S. Copyright Office as the Designated Service Provider Agent to receive notifications of alleged Copyright infringement with respect to users of the Service provided by **Youtube LLC** for which you are the Designated Agent.

SI-CERT is the Slovenian Computer Emergency Response Team which by the decision of the Government of the Republic of Slovenia no. 38600-3/2009/21 of 08 April 2010 is the designated Government CERT of Slovenia.

1. The material which I contend belongs to the Secretariat-General of the Government of Slovenia, and appears illegally on the Service is the following:
